Purpose – The informed consent form provides The Tree House Child Care Center with the preferences of the families of the children in care. The center's Informed Consent complements the Family

Handbook and is completed during the enrollment process. Evacuation Drill Permission - The Tree House Child Care Center will practice emergency evacuation drills at various times throughout the year which may require walking your child to a defined alternative evacuation site. Parents/families will be notified in advance of when drills will take place. As a parent/guardian of a child enrolled in The Three House Child Care Center, I: Grant Denv Permission for my child to participate in emergency evacuation drills. Occasionally children's photos may be used for promotional purposes (events, website, social media). Recordings, videos and photographs of children enrolled in The Tree House Child Care Center will only be taken on devices owned by the center and never on a staff, visitors or guest's personal phone or device. Parent Initials Solicitation - As a parent/guardian, I agree I will not solicit directly or indirectly an employee of The

Three House Child Care Center to enter into an employment contract/agreement for a minimum of 6 months following the end of employment with The Tree House Child Care Center. I understand that The Tree House Child Care Center has incurred costs to employ qualified staff. Therefore, I agree that if I violate the solicitation clause, I agree to pay The Tree House Child Care Center a minimum of \$1,500 plus any legal or court fees associated with the breech.

Parent/Guardian Code of Conduct - Parents/guardians of children enrolled in care at The Tree House Child Care Center are asked to behave in a way that is in alignment with our mission and program philosophy. Parents/guardians in violation of this code will not be allowed on the property of The Tree House Child Care Center thereafter. Parent/guardian code of conduct includes:

- Cursing or use of inappropriate language on-site, at any time, directed at anyone.
- Making threats of any kind. The center will immediately report a threat of any kind.
- The use of corporal punishment is not permitted on property of The Three House Child Care
 Center. Parents are prohibited from directing corrective actions towards a child that is not their
 own. It is recognized that parental reprimands of their own children may be appropriate at
 times and families are encouraged to discuss behavior with staff.
- The use of drugs, alcohol and smoking are prohibited at any time while on the property of The Tree House Child Care Center.
- The Tree House Child Care Center is a weapon free property and facility. Parents may not carry a weapon at any time while on property or in the facility despite having a permit.
- Parents/guardians of children enrolled in services should restrain from engaging in relationship with staff while staff are employed by The Tree House Child Care Center.
- Parents/guardians will share differences of opinion directly to and only with staff of The Three House Child Care Center and will work to resolve conflicts respectfully and collaboratively.
